

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-1120**

*Affirmed*  
*Late Request for Hearing Dismissed*

**PROCEDURAL HISTORY:** On July 27, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to provide information in accordance with the Department's rules and therefore was ineligible to receive unemployment insurance benefits for the week including July 3, 2022 through July 9, 2022 (week 27-22) and until the reason for the denial had ended (decision # 597129). On August 16, 2022, decision # 597129 became final without claimant having filed a request for hearing. On September 19, 2022, claimant filed a late request for hearing. On October 20, 2022, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for November 2, 2022 on whether claimant's late request for hearing should be allowed and, if so, the merits of decision # 597129. On November 2, 2022, ALJ Blam-Linville conducted a hearing, and on November 4, 2022, issued Order No. 22-UI-206686, dismissing claimant's request for hearing on decision # 597129 as late without a showing of good cause, and leaving decision # 597129 undisturbed. On November 8, 2022, claimant filed an application for review of Order No. 22-UI-206686 with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** Under ORS 657.275(2) and OAR 471-041-0090(1)(b)(A) (May 13, 2019), EAB did not consider claimant's argument because it was not relevant and material to EAB's determination of whether claimant's late request for hearing on decision # 597129 should be allowed.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 22-UI-206686 is affirmed.
