

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-1137**

*Affirmed*  
*Late Request for Hearing Dismissed*

**PROCEDURAL HISTORY:** On August 10, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to provide information in accordance with the Department's rules and therefore was ineligible to receive unemployment insurance benefits for the week including July 18, 2021 through July 24, 2021 (week 29-21) and until the reason for the denial had ended. On August 30, 2021, the August 10, 2021 administrative decision became final without claimant having filed a request for hearing. On March 3, 2022, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on June 6, 2022, issued Order No. 22-UI-195410, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by June 20, 2022. On June 20, 2022, claimant filed a timely response to the appellant questionnaire. On August 22, 2022, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 22-UI-195410 was vacated and that a hearing would be scheduled to determine whether claimant had good cause to file the late request for hearing and, if so, the merits of the August 10, 2021 administrative decision.

On October 20, 2022, ALJ Frank conducted a hearing, and on October 27, 2022 issued Order No. 22-UI-206030, dismissing claimant's request for hearing as late without a showing of good cause, and leaving the August 10, 2021 administrative decision undisturbed. On November 15, 2022, claimant filed an application for review of Order No. 22-UI-206030 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 22-UI-206030 is affirmed.
