

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-1150**

*Application for Review Dismissed*

**PROCEDURAL HISTORY:** On February 2, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision denying claimant's request for a waiver of an overpayment previously assessed by the Department on September 21, 2021 (decision # 140356). Claimant filed a timely request for hearing. On October 26, 2022, ALJ Frank conducted a hearing, and on November 3, 2022 issued Order No. 22-UI-206616, affirming decision # 140356 by concluding that claimant's request for a waiver of the overpayment was moot because claimant had been absolved of his liability for the overpayment. On November 18, 2022, claimant filed an application for review with the Employment Appeals Board (EAB). On December 6, 2022, claimant filed a request to withdraw the November 18, 2022 application for review.<sup>1</sup>

**FINDING OF FACT:** On December 6, 2022, claimant sent an email to EAB asking to withdraw their application for review of Order No. 22-UI-206616.

**CONCLUSIONS AND REASONS:** Claimant's application for review is dismissed.

OAR 471-041-0098 (October 29, 2006) provides that an applicant's written request to withdraw an application for review will be allowed unless the request is received after EAB's decision has been issued.

<sup>1</sup> The Department also filed a request to withdraw the application for review of Order No. 22-UI-206616. However, as the Department did not file the application for review of Order No. 22-UI-206616, the Department is not permitted to withdraw the request under OAR 471-041-0098.

On December 6, 2022, EAB received a written request, by email, in which claimant withdrew the application for review of Order No. 2022-UI-206616. EAB had not yet issued a decision. Under OAR 471-041-0098, claimant's request to withdraw the application for review is allowed.

**DECISION:** The application for review filed November 18, 2022 is dismissed. Order No. 22-UI-206616 remains undisturbed.
