# EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-1152

Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On September 30, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision assessing an overpayment of \$3,638 in regular unemployment insurance (regular UI) benefits that claimant was required to repay to the Department and an overpayment of \$8,400 in Federal Pandemic Unemployment Compensation (FPUC) benefits to be repaid by deduction from future benefits payable (decision # 125707). On October 20, 2021, decision # 125707 became final without claimant having filed a request for hearing. On November 2, 2021, claimant filed a late request for hearing on decision # 125707. ALJ Kangas considered claimant's request, and on January 7, 2022, mailed Order No. 22-UI-183543, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by January 21, 2022. Order No. 22-UI-183543 was returned as undeliverable. On January 25, 2022, ALJ Kangas issued Amended Order No. 22-UI-184705, mailed to an updated address for claimant, which dismissed claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by February 8, 2022. On February 14, 2022, Amended Order No. 22-UI-184705 became final without claimant having filed a response to the appellant questionnaire or a timely application for review. On March 14, 2022, claimant filed a late response to the appellant questionnaire. On May 18, 2022, ALJ Kangas mailed a letter stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue another order regarding this matter because the questionnaire response was late. On November 21, 2022, claimant filed a late application for review of Amended Order No. 22-UI-184705.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement claimant provided with their application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**FINDING OF FACT:** (1) Amended Order No. 22-UI-184705, mailed to claimant on January 25, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the

Employment Appeals Board within 20 days of the date that this decision is mailed." Amended Order No. 22-UI-184705 at 2. Amended Order No. 22-UI-184705 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than February 14, 2022."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Amended Order No. 22-UI-184705 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Amended Order No. 22-UI-184705 was due February 14, 2022. Because claimant did not file their application for review until November 21, 2022, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented him from filing the application for review on time. *See* EAB Exhibit 1. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed November 21, 2022 is dismissed. Amended Order No. 22-UI-184705 remains undisturbed.
