

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-1154**

*Application for Review Dismissed*

**PROCEDURAL HISTORY:** On September 21, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain benefits, and assessing an overpayment of \$35,340 in combined regular unemployment insurance (regular UI), Pandemic Emergency Unemployment Compensation (PEUC), Extended Benefit (EB), Federal Pandemic Unemployment Compensation (FPUC), and Lost Wages Assistance (LWA) benefits that claimant was required to repay to the Department, a \$5,031 monetary penalty, and a 52 week penalty disqualification from future benefits. Claimant filed a timely request for hearing. On October 26, 2022, ALJ Frank conducted a hearing, and on November 3, 2022 issued Order No. 22-UI-206614, reversing the September 21, 2021 administrative decision by concluding that claimant did not willfully make a misrepresentation of material fact, the Department did not overpay claimant benefits that he was required to repay to the Department, and claimant was not liable for a monetary penalty or penalty disqualification. On November 21, 2022, the Department filed an application for review with the Employment Appeals Board (EAB). On November 28, 2022, the Department filed a request to withdraw the November 21, 2022 application for review.

**FINDING OF FACT:** On November 28, 2022, the Department sent an email to EAB asking to withdraw their application for review of Order No. 22-UI-206614.

**CONCLUSIONS AND REASONS:** The Department's application for review is dismissed.

OAR 471-041-0098 (October 29, 2006) provides that an applicant's written request to withdraw an application for review will be allowed unless the request is received after EAB's decision has been issued.

On November 21, 2022, EAB received a written request, by email, in which the Department withdrew the application for review of Order No. 22-UI-206614. EAB had not yet issued a decision. Under OAR 471-041-0098, the Department's request to withdraw the application for review is allowed.

**DECISION:** The application for review filed November 21, 2022 is dismissed. Order No. 22-UI-206614 remains undisturbed.
