

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-1162**

*Affirmed*  
*Benefits Denied*

**PROCEDURAL HISTORY:** On September 14, 2022, the Oregon Employment Department (the Department) served notice of four administrative decisions denying claimant benefits for the weeks from May 30 through June 26, 2021 (decision # 133500), July 18 through August 28, 2021 (decision # 133924), August 29 through October 9, 2021 (decision # 134256), and October 10 through November 13, 2021 (decision # 134556), because claimant's weekly claims for those weeks were late. Claimant filed a timely request for hearing on the September 14, 2022 administrative decisions. On October 31, 2022, ALJ Blam-Linville conducted a consolidated hearing on decisions # 133500, 133924, 134256, and 134556. On November 3, 2022, Blam-Linville issued Order No. 22-UI-206569 affirming decision # 133924, and Order No. 22-UI-206566 affirming decision # 134556. On November 4, 2022, ALJ Blam-Linville issued Order No. 22-UI-206666 affirming decision # 133500, and Order No. 22-UI-206665 affirming decision # 134256. On November 21, 2022, claimant filed an application for review of Orders No. 22-UI-206569, 22-UI-206566, 22-UI-206666, and 22-UI-206665 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 22-UI-206569, 22-UI-206566, 22-UI-206666, and 22-UI-206665. For case-tracking purposes, this decision is being issued in quadruplicate (EAB Decisions 2022-EAB-1160, 2022-EAB-1159, 2022-EAB-1162, and 2022-EAB-1161).

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 22-UI-206569, 22-UI-206566, 22-UI-206666, and 22-UI-206665 are affirmed.
