EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-1174-R

Request for Reconsideration Allowed EAB Decision 2022-EAB-1174 Adhered to on Reconsideration

PROCEDURAL HISTORY: On October 3, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was denied benefits for the week of August 28, 2022 through September 3, 2022 (week 35-22) because his claim for that week was late (decision # 92523). Claimant filed a timely request for hearing. On November 7, 2022, ALJ S. Roberts conducted a hearing, and on November 9, 2022 issued Order No. 22-UI-206996, reversing decision # 92523 by concluding that claimant was eligible for benefits for week 35-22. On November 28, 2022, the Department filed an application for review with the Employment Appeals Board (EAB). On January 31, 2023, EAB issued EAB Decision 2022-EAB-1174, affirming Order No. 22-UI-206996 by adopting its findings of fact and conclusions of law. On February 21, 2023, the Department filed a timely request for reconsideration of EAB Decision 2022-EAB-1174. This decision is issued pursuant to EAB's authority under ORS 657.290(3).

CONCLUSIONS AND REASONS: The Department's request for reconsideration is allowed. EAB Decision 2022-EAB-1174 is adhered to on reconsideration.

ORS 657.290(3) authorizes EAB to reconsider any previous decision of the Employment Appeals Board, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment Department practice." OAR 471-041-0145(1) (May 13, 2019).

The Department filed a request for reconsideration consistent with the requirements set forth in OAR 471-041-0145. The request for reconsideration is, therefore, allowed.

In their request, the Department disputed the outcome of the EAB decision under reconsideration because "per OAR 471-030-0079(9) there is no good cause exception for late weekly claims filed under the Work Share program." Oregon Employment Department's Request for Reconsideration at 1. This point was addressed in Order No. 22-UI-206996, as adopted by the EAB decision under reconsideration.

As explained in that order, the fact that the Department's rules allow neither a good cause exception for late-filed Work Share claims, nor any opportunity for an individual claimant to file timely claims on their own behalf, does not comport with "principles of due process or fairness." Order No. 22-UI-206996 at 2. The Department offered no argument to contradict this analysis. Thus, the Department's restatement of its rule does not constitute the correction of an error of law and is not a basis for reversing the decision under reconsideration.

For the above reasons, EAB Decision 2022-EAB-1174 is adhered to on reconsideration.

DECISION: The Department's request for reconsideration is allowed. On reconsideration, EAB Decision 2022-EAB-1174 is adhered to.
