

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-1185

Affirmed
Late Request to Reopen Denied
Disqualification

PROCEDURAL HISTORY: On August 20, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was disqualified from receiving unemployment insurance benefits effective October 25, 2020 (decision # 133450). Claimant filed a timely request for hearing. On February 17, 2022, the Office of Administrative Hearings (OAH) served notice of a hearing on decision # 133450 scheduled for March 3, 2022 at 7:00 a.m. On March 3, 2022, claimant failed to appear for the hearing, and ALJ Ramey issued Order No. 22-UI-187786 dismissing the hearing request on decision # 133450 due to claimant's failure to appear. On March 23, 2022, Order No. 22-UI-187786 became final without claimant having filed a request to reopen the March 3, 2022 hearing with OAH or an application for review with the Employment Appeals Board (EAB). On October 23, 2022, claimant filed a late request to reopen the March 3, 2022 hearing. ALJ Kangas considered claimant's request, and on November 9, 2022 issued Order No. 22-UI-206950, dismissing claimant's late request to reopen and the March 3, 2022 hearing on decision # 133450, and leaving Order No. 22-UI-187786 undisturbed. On November 29, 2022, claimant filed an application for review of Order No. 22-UI-206950 with EAB.

WRITTEN ARGUMENT: Claimant did not declare that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information into the hearing record with their request to reopen the March 3, 2022 hearing, as required by OAR 471-040-0041(4). EAB considered only information received into the hearing record when reaching this decision. See ORS 657.275(2); OAR 471-041-0090 (May 13, 2019).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 22-UI-206950 is affirmed.
