EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-1188-R

Request for Reconsideration Allowed EAB Decision 2022-EAB-1188 Adhered to on Reconsideration

PROCEDURAL HISTORY: On October 14, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant filed a late claim for unemployment insurance benefits for the week of September 18, 2022 through September 24, 2022 (week 38-22) and therefore was denied unemployment insurance benefits for that week (decision # 112922). Claimant filed a timely request for hearing. On November 9, 2022, ALJ Logan conducted a hearing at which the employer failed to appear, and on November 10, 2022 issued Order No. 22-UI-207058, affirming decision # 112922. On November 29, 2022, claimant filed an application for review with the Employment Appeals Board (EAB). On February 3, 2023, EAB issued EAB Decision 2022-EAB-1188, reversing Order No. 22-UI-207058 by concluding that claimant was eligible to receive benefits for week 38-22. On February 21, 2023, the Department filed a timely request for reconsideration of EAB Decision 2022-EAB-1188. This decision is issued pursuant to EAB's authority under ORS 657.290(3).

CONCLUSIONS AND REASONS: The Department's request for reconsideration is allowed. EAB Decision 2022-EAB-1188 is adhered to on reconsideration.

ORS 657.290(3) authorizes EAB to reconsider any previous decision of the Employment Appeals Board, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment Department practice." OAR 471-041-0145(1) (May 13, 2019).

The Department filed a request for reconsideration consistent with the requirements set forth in OAR 471-041-0145. The request for reconsideration is, therefore, allowed.

In their request, the Department disputed the outcome of the EAB decision under reconsideration because "per OAR 471-030-0079(9) there is no good cause exception for late weekly claims filed under the Work Share program." Oregon Employment Department's Request for Reconsideration at 1. This point was addressed in the EAB decision under reconsideration. As EAB explained in that decision, the fact that the Department's rules allow neither a good cause exception for late-filed Work Share claims, nor any opportunity for an individual claimant to file timely claims on their own behalf, constitutes a due process violation. EAB Decision 2022-EAB-1188 at 2. The Department offered no argument to contradict this analysis. Thus, the Department's restatement of its rule does not constitute the correction of an error of law and is not a basis for reversing the decision under reconsideration.

The Department's argument also contained information regarding the Work Share program that was not part of the hearing record, and did not show that factors or circumstances beyond the Department's reasonable control prevented them from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into evidence at the hearing when reconsidering this decision. *See* ORS 657.275(2).

For the above reasons, EAB Decision 2022-EAB-1188 is adhered to on reconsideration.

DECISION: The Department's request for reconsideration is allowed. On reconsideration, EAB Decision 2022-EAB-1188 is adhered to.
