EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-1208

Late Application for Review Dismissed

PROCEDURAL HISTORY: On April 15, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant, but not for misconduct, and claimant was not disqualified from receiving benefits based on the work separation (decision # 93149). The employer filed a timely request for hearing. On June 16, 2021, ALJ Frank conducted a hearing, and on June 17, 2021 issued Order No. 21-UI-168954, reversing decision # 93149 by concluding that claimant was discharged, not for misconduct, within 15 days of a planned quit without good cause, and was disqualified from receiving benefits effective March 21, 2021 but was eligible to receive benefits before that date. On July 7, 2021, Order No. 21-UI-168954 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On October 27, 2022, claimant filed a late application for review of Order No. 21-UI-168954 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's statements included with the October 27, 2022 application for review, and an additional statement included in an email to the Office of Administrative Hearings (OAH) on November 7, 2022. This evidence has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 21-UI-168954, mailed to claimant on June 17, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-168954 at 5. Order No. 21-UI-168954 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before July 7, 2021 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 21-UI-168954 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-168954 was due by July 7, 2021. Because claimant did not file their application for review until October 27, 2022, the application for review was late. Claimant provided written statements with and following the application for review. However, claimant's written statements did not describe the circumstances that prevented them from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed October 27, 2022 is dismissed. Order No. 21-UI-168954 remains undisturbed.
