EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-1218

Late Application for Review Dismissed

PROCEDURAL HISTORY: On September 15, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to register for work in accordance with the Department's rules and was therefore denied unemployment insurance benefits for the week of August 28, 2022 through September 3, 2022 (week 35-22) and until the reason for the denial had ended. Claimant filed a timely request for hearing. On November 9, 2022, ALJ Wardlow conducted a hearing and on November 14, 2022, issued Order No. 22-UI-207182, modifying the September 15, 2022 administrative decision by concluding that claimant failed to register for work in accordance with the Department's rules and was denied benefits for the weeks including August 28, 2022 through September 24, 2022 (weeks 35-22 through 38-22). On December 5, 2022, Order No. 22-UI-207182 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On December 8, 2022, claimant filed a late application for review of Order No. 22-UI-207182 with EAB.

FINDING OF FACT: (1) Order No. 22-UI-207182, mailed to claimant on November 14, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-207182 at 4. Order No. 22-UI-207182 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before December 5, 2022 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 22-UI-207182 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it

includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-207182 was due by December 5, 2022. Because claimant did not file their application for review until December 8, 2022, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented claimant from filing the application for review by the December 5, 2022 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed December 8, 2022 is dismissed. Order No. 22-UI-207182 remains undisturbed.
