EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-1222

Late Application for Review Dismissed Without Prejudice

PROCEDURAL HISTORY AND FINDINGS OF FACT: On December 14, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received benefits to which they were not entitled and assessing an overpayment of \$1800.00 in Lost Wage Assistance payments that claimant was required to repay to the Department (decision # 564036). On January 3, 2022, decision # 564036 became final without claimant having filed a request for hearing. On August 10, 2022, claimant filed a late request for hearing. ALJ Kangas considered the request and on November 16, 2022 issued Order No. 22-UI-207530, dismissing claimant's late request for hearing subject to claimant's right to renew the request by responding to an appellant questionnaire by November 30, 2022. On December 6, 2022, Order No. 22-UI-207530 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On December 9, 2022, claimant filed a late application for review with EAB.

CONCLUSIONS AND REASONS: The application for review is dismissed without prejudice.

On December 9, 2022, the appellant filed an application for review of Order No. 22-UI-207530 with EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than December 6, 2022. The appellant's application for review is therefore late, and this application for review is dismissed.

The deadline for filing an application for review may be extended a reasonable time upon a showing of good cause. *See* ORS 657.875; OAR 471-041-0070 (May 13, 2019). If the appellant believes they have good cause and filed their late application for review within a reasonable time, the appellant may request that EAB reconsider this decision under OAR 471-041-0145 (May 13, 2019).

EAB will dismiss any request for reconsideration that does not include **all five** of the following:

- The appellant must file the request for reconsideration within 20 days of the date this decision was mailed; the date this decision was mailed is January 18, 2023, making the deadline February 7, 2023¹ to file the request for reconsideration, *and*
- 2. The appellant must include a statement on the request for reconsideration declaring that they sent a copy of the request to the other party, *and*
- 3. The appellant must provide additional specific details about the reason they filed a late application for review. For example, the appellant should include specific information about the date they received the ALJ's order, whether they read it, whether they agreed or disagreed with the ALJ's order, the reason(s) why they did not file the application for review before the deadline, how the reason(s) affected their ability to file a timely application for review, when they met with and obtained counsel, how the meeting with counsel effected the time of their filing, and any other specific details that might help EAB determine whether or not the appellant had "good cause," which means factors or circumstances beyond their reasonable control prevented them from filing a timely application for review, *and*
- 4. The appellant must provide the date the circumstances that prevented them from filing a timely application for review (which they listed in response to #3, above) ceased to exist, *and*
- 5. The appellant must provide sufficient information to prove that they filed their application for review within seven days of that date.

The appellant may file a request for reconsideration in many ways; please note that you need only file *one* request for reconsideration:

- 1. Use your smart phone, tablet, or computer to fill out the "File a Written Argument" form, available on EAB's website: <u>https://www.oregon.gov/EMPLOY/EAB/Pages/default.aspx</u>, *or*
- 2. Use your smart phone, tablet, or computer to send an email to EAB at <u>OED_EAB_OFFICE@employ.oregon.gov</u>, *or*
- 3. Send the request by U.S. mail or another delivery service, addressed to 875 Union St NE, Salem, Oregon 97311, *or*
- 4. Send EAB a fax at 503-378-2129.

DECISION: The application for review filed December 9, 2022 is dismissed without prejudice. Order No. 22-UI-207530 remains undisturbed.
