EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-1232

Late Application for Review Dismissed

PROCEDURAL HISTORY: On March 16, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was overpaid \$1,134 in Trade Reinvestment Act benefits that she was required to repay (decision # 122832). On April 5, 2022, decision # 122832 became final without claimant having requested a hearing. On August 3, 2022, claimant filed a late request for hearing on decision # 122832. ALJ Kangas considered claimant's request, and on November 10, 2022, issued Order No. 22-UI-207148, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by November 24, 2022. On November 30, 2022, Order No. 22-UI-207148 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On December 5, 2022, claimant filed a response to the appellant questionnaire and late application for review of Order No. 22-UI-207148 with EAB. On December 13, 2022, ALJ Kangas mailed a letter to claimant stating that because claimant's response to the appellant questionnaire was late, it would not be considered, another order would not be issued, and Order No. 22-UI-207148.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the appellant questionnaire response claimant included with his application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

FINDING OF FACT: (1) Order No. 22-UI-207148, mailed to claimant on November 10, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-207148 at 2. Order No. 22-UI-207148 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than November 30, 2022."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 22-UI-207148 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-207148 was due by November 30, 2022. Because claimant did not file her application for review until December 5, 2022, the application for review was late. The only written statement claimant included with her application for review was claimant's response to the appellant questionnaire, which did not describe circumstances that prevented claimant from filing the application for review on time. Accordingly, claimant did not show good cause for her late application for review, and the late application for review is dismissed.

DECISION: The application for review filed December 5, 2022 is dismissed. Order No. 22-UI-207148 remains undisturbed.
