EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-1233

Affirmed Eligible Week 41-22 Ineligible Weeks 42-22 through 43-22

PROCEDURAL HISTORY: On October 31, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not able to work and did not actively seek work from October 16 through 22, 2022 (week 42-22) and therefore was ineligible for benefits for that week (decision # 132447). On November 1, 2022, the Department served notice of an administrative decision concluding that claimant failed to provide information in accordance with the Department's rules and therefore was ineligible for benefits from October 9 through 22, 2022 (weeks 41-22 through 42-22) and until the reason for the denial had ended (decision # 610193). Claimant filed timely requests for hearing on decisions # 132447 and 610193. On December 7, 2022, ALJ Mott conducted a hearing on both administrative decisions. On December 8, 2022, ALJ Mott issued Order No. 22-UI-209330, affirming decision # 132447 by concluding that claimant was ineligible for benefits for week 42-22. Also on December 8, 2022, ALJ Mott issued Order No. 22-UI-209329, modifying decision # 610193 by concluding that claimant was eligible for benefits for weeks 41-22 and 42-22, but was ineligible for benefits from October 23 through 29, 2022 (week 43-22). On December 13, 2022, claimant filed applications for review of Orders No. 22-UI-209330 and 22-UI-209329 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 22-UI-209330 and 22-UI-209329. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2022-EAB-1231 and 2022-EAB-1233).

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090

¹ Claimant should note that while Order No. 22-UI-209329 concluded that she was eligible for benefits during week 42-22 on the basis that she had not failed to provide information in accordance with the Department's rules for that week, she nevertheless remains ineligible for benefits during week 42-22 because Order No. 22-UI-209330, affirmed herein, concluded that she was not able to work during that week.

(May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's argument to the extent it was based on the record.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 22-UI-209330 and 22-UI-209329 are affirmed.
