

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-1239

Late Application for Review Dismissed
No Justiciable Controversy

PROCEDURAL HISTORY AND FINDINGS OF FACT: On October 27, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant filed a late claim for benefits for the week of September 5, 2021 through September 11, 2021 (week 36-21) and was denied benefits for that week (decision # 123702). Claimant filed a timely request for hearing. On November 16, 2022, ALJ Monroe conducted a hearing, and on November 23, 2022 issued Order No. 22-UI-208181, reversing decision # 123702 by concluding that claimant filed a timely claim for benefits for week 36-21 and was allowed benefits for that week. On December 13, 2022, Order No. 22-UI-208181 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On December 14, 2022, claimant filed a late application for review of Order No. 22-UI-208181 with EAB.

CONCLUSIONS AND REASONS: Claimant's application for review of Order No. 22-UI-208181 presents no justiciable controversy and is dismissed.

On December 14, 2022, claimant filed with EAB a late application for review of Order No. 22-UI-208181, which allowed the appellant benefits. Claimant did not assign error to any portion of Order No. 22-UI-208181, did not request reversal of any portion of Order No. 22-UI-208181, and alleged no facts entitling him to further relief in this matter. Accordingly, there is no justiciable controversy before EAB based upon claimant's late application for review of Order No. 22-UI-208181. *See accord Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995). Because this case before EAB presents no justiciable controversy, the late application for review of Order No. 22-UI-208181 is dismissed and the order remains undisturbed.

DECISION: The application for review of Order No. 22-UI-208181 filed December 14, 2022 is dismissed. Order No. 22-UI-208181 remains undisturbed.
