

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-1244**

*Affirmed*  
*Disqualification*

**PROCEDURAL HISTORY:** On November 3, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to provide information to the Department as required by the Department's rules and was not eligible for benefits from October 16 through 22, 2022 and until the reason for the denial had ended. Claimant filed a timely request for hearing. On December 5, 2022, ALJ Lucas conducted a hearing, and on December 7, 2022 issued Order No. 22-UI-209107, modifying the November 3, 2022 administrative decision by concluding claimant was not eligible for unemployment insurance benefits from October 16 through November 5, 2022. On December 16, 2022, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 22-UI-209107 is affirmed.
