

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-1246

Late Application for Review Dismissed

PROCEDURAL HISTORY: On September 27, 2021, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not eligible for PUA benefits effective December 27, 2020. On October 18, 2021, the September 27, 2021 PUA determination became final without claimant having requested a hearing. On June 29, 2022, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on October 4, 2022 issued Order No. 22-UI-204148, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by October 18, 2022. On October 24, 2022, Order No. 22-UI-204148 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On December 7, 2022, claimant filed a late response to the appellant questionnaire and late application for review of Order No. 22-UI-204148 with EAB. On December 12, 2022, ALJ Kangas mailed a letter to claimant stating that because claimant's response to the appellant questionnaire was late, it would not be considered, another order would not be issued, and Order No. 22-UI-204148 remained in effect. This matter comes before EAB based upon claimant's December 7, 2022 application for review of Order No. 22-UI-204148.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the appellant questionnaire response claimant included with their application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to EAB admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 22-UI-204148, mailed to claimant on October 4, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-204148 at 2. Order No. 22-UI-204148 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than October 24, 2022."

CONCLUSIONS AND REASONS: Claimant’s late application for review of Order No. 22-UI-204148 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-204148 was due by October 24, 2022. Because claimant did not file their application for review until December 7, 2022, the application for review was late. Claimant provided a written statement with the application for review. However, claimant’s written statement did not describe circumstances that prevented claimant from filing the application for review on time. Accordingly, claimant did not show good cause for their late application for review, and the late application for review is dismissed.

DECISION: The application for review filed December 7, 2022 is dismissed. Order No. 22-UI-204148 remains undisturbed.
