EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-1251

Late Application for Review Dismissed

PROCEDURAL HISTORY: On April 20, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant had failed to register for work in accordance with the Department's rules and therefore was ineligible to receive unemployment insurance benefits for the week of April 3, 2022 through April 9, 2022 (week 14-22) and until the reason for the denial had ended. Claimant filed a timely request for hearing. On August 25, 2022, ALJ Logan conducted a hearing, and on September 2, 2022, issued Order No. 22-UI-202003, modifying the April 20, 2022 administrative decision by concluding that claimant had failed to register for work in accordance with the Department's rules and therefore was ineligible to receive benefits for the weeks including April 3, 2022 through April 16, 2022 (weeks 14-22 and 15-22). On September 22, 2022, Order No. 22-UI-202003 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On December 17, 2022, claimant filed a late application for review of Order No. 22-UI-202003 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's written statement, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 22-UI-202003, mailed to claimant on September 2, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-202003 at 3. Order No. 22-UI-202003 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before September 22, 2022 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 22-UI-202003 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-202003 was due September 22, 2022. Because claimant did not file their application for review until December 17, 2022, the application for review was late. Claimant provided a written statement with their application for review stating that they wanted to reopen the hearing and disagreed with the order. EAB Exhibit 1. However, claimant's written statement did not describe the circumstances that prevented claimant from filing the application for review on time. EAB Exhibit 1. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed December 17, 2022 is dismissed. Order No. 22-UI-202003 remains undisturbed.
