EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0051

Late Application for Review Dismissed

PROCEDURAL HISTORY: On February 15, 2022, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to PUA benefits effective December 27, 2020. On March 7, 2022, the February 15, 2022 PUA determination became final without claimant having filed a request for hearing. On March 15, 2022, claimant filed a late request for hearing. ALJ Kangas considered the request, and on June 15, 2022 issued Order No. 22-UI-196184, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by June 29, 2022. On June 20, 2022 claimant responded to the appellant questionnaire. On August 11, 2022, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 22-UI-196184 was cancelled and vacated, and that a hearing would be held on whether claimant's late request for hearing should be allowed and, if so, the merits of the February 15, 2022 pUA determination. On August 31, 2022, ALJ Frank conducted the hearing, and on September 8, 2022 issued Order No. 22-UI-202259, dismissing claimant's late request for hearing as without good cause, leaving the February 15, 2022 PUA determination for review of Order No. 22-UI-202259 with the Employment Appeals Board (EAB).

On November 18, 2022, EAB issued Appeals Board Decision 2022-EAB-0981, reversing Order No. 22-UI-202259 and remanding the matter to OAH for a hearing on the merits of the February 15, 2022 PUA determination. On December 12, 2022, ALJ Frank conducted the hearing, and on December 15, 2022 issued Order No. 22-UI-210037, modifying the February 15, 2022 PUA determination by concluding that claimant was not entitled to receive PUA benefits from December 27, 2020 through March 6, 2021, March 21 through June 5, 2021, July 4 through July 17, 2021, July 25 through August 7, 2021, and August 29 through September 4, 2021 (weeks 53-20 through 09-21, 12-21 and 22-21, 27-21 and 28-21, 30-21 and 31-21, and 35-21). On January 4, 2023, Order No. 22-UI-210037 became final without claimant having filed an application for review with EAB. On January 5, 2023, claimant filed a late application for review of Order No. 22-UI-210037 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement claimant provided with their application for review, and has been marked as EAB Exhibit 1, and a copy provided

to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 22-UI-210037, mailed to claimant on December 15, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-210037 at 4. Order No. 22-UI-210037 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than January 4, 2023."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 22-UI-210037 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-210037 was due by January 4, 2023. Because claimant did not file their application for review until January 5, 2023, the application for review was late. Claimant provided a written statement with the application for review. Although claimant's written statement described why they disagreed with Order No. 22-UI-210037, the statement did not describe the circumstances that prevented claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed January 5, 2023 is dismissed. Order No. 22-UI-210037 remains undisturbed.
