

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0052

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On December 10, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to provide information in accordance with the Department's rules and was ineligible for benefits from August 1, 2021 through August 14, 2021 (weeks 31-21 through 32-21) and until the reason for the denial had ended (decision # 151829). On December 30, 2021, decision # 151829 became final without claimant having filed a request for hearing. On January 3, 2022, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on March 15, 2022 issued Order No. 22-UI-188706, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by March 29, 2022.

On March 21, 2022, claimant filed a timely response to the appellant questionnaire. On May 26, 2022, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 22-UI-188706 was vacated and that a hearing would be scheduled to determine whether claimant's late request for hearing should be allowed and, if so, the merits of decision # 151829. On December 19, 2022, ALJ Davis conducted a hearing, and on December 20, 2022 issued Order No. 22-UI-210403, re-dismissing claimant's request for hearing as late without good cause, leaving decision # 151829 undisturbed. On January 5, 2023, claimant filed an application for review of Order No. 22-UI-210403 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's argument to the extent it was based on the record.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 22-UI-210403 is affirmed.
