# EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0059

Late Application for Review Dismissed

PROCEDURAL HISTORY: On June 1, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant filed late claims for benefits for the weeks from March 15, 2020 through May 15, 2021 (weeks 12-20 through 19-21) and therefore was ineligible for benefits for those weeks (decision # 65820). Claimant filed a timely request for hearing. On October 18, 2021, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for October 28, 2021. On October 28, 2021, claimant failed to appear at hearing, and on October 29, 2021, ALJ Lucas issued Order No. 21-UI-178447 dismissing claimant's request for hearing for failure to appear. On November 16, 2021, claimant filed a timely request to reopen the hearing. ALJ Kangas considered the request to reopen, and on March 3, 2022 issued order 22-UI-187811, denying the request. On March 23, 2022, Order No. 22-UI-187811 became final without claimant having filed an application for review. On January 9, 2023 claimant filed a late application for review of Order No. 22-UI-187811 with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's written argument, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**FINDING OF FACT:** (1) Order No. 22-UI-187811, mailed to claimant on March 3, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-187811 at 3.

Order No. 22-UI-187811 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before March 23, 2022 to be timely."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 22-UI-187811 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-187811 was due by March 23, 2022. Because claimant did not file their application for review until January 9, 2023, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe circumstances preventing claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed January 9, 2023 is dismissed. Order No. 22-UI-187811 remains undisturbed.
