# EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0064

Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On July 20, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to provide information in accordance with the Department's rules and therefore was ineligible to receive unemployment insurance benefits for the week of June 26, 2022 through July 2, 2022 (week 26-22), and until the reason for the denial had ended (decision # 596081). On August 9, 2022, decision # 596081 became final without claimant having filed a request for hearing. On August 12, 2022, claimant filed a late request for hearing on decision # 596081. ALJ Kangas considered claimant's request, and on November 16, 2022 issued Order No. 22-UI-207499, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by November 30, 2022. On December 6, 2022, Order No. 22-UI-207499 became final without claimant having filed an appellant questionnaire response or application for review with the Employment Appeals Board (EAB). On December 13, 2022, claimant filed a late response to the appellant questionnaire and a late application for review of Order No. 22-UI-207499 with EAB. On January 12, 2023, ALJ Kangas mailed a letter stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue another order regarding this matter because the questionnaire response was late. This matter comes before EAB based upon claimant's late application for review of Order No. 22-UI-207499.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement claimant provided with their application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**FINDING OF FACT:** (1) Order No. 22-UI-207499, mailed to claimant on November 16, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-207499 at 2. Order No. 207499 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than December 6, 2022."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 22-UI-207499 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-207499 was due by December 6, 2022. Because claimant did not file their application for review until December 13, 2022, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed December 13, 2022 is dismissed. Order No. 22-UI-207499 remains undisturbed.
