EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0067

Late Applications for Review Dismissed

PROCEDURAL HISTORY: On December 9, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and therefore was disqualified from receiving unemployment insurance benefits effective March 29, 2020 (decision # 121758). On December 29, 2020, decision # 121758 became final without claimant having filed a request for hearing. On December 15, 2021, the Department served notice of an administrative decision, based in part on decision # 121758, concluding that claimant received benefits to which they were not entitled and assessing an overpayment of \$1,800 in Lost Wages Assistance (LWA) benefits that claimant was required to repay to the Department (decision # 0564275). On January 4, 2022, decision # 0564275 became final without claimant having filed a request for hearing. On April 14, 2022, claimant filed late requests for hearing on decisions # 121758 and 0564275.

ALJ Kangas considered claimant's requests, and on August 17, 2022 issued Orders No. 22-UI-200678 and 22-UI-200677, dismissing claimant's requests for hearing on decisions # 121758 and 0564275, respectively, as late, subject to claimant's right to renew the requests by responding to an appellant questionnaire by August 31, 2022. On September 6, 2022, Orders No. 22-UI-200678 and 22-UI-200677 became final without claimant having filed a response to the appellant questionnaire or applications for review with the Employment Appeals Board (EAB). On October 25, 2022, claimant filed a late response to the appellant questionnaire and late applications for review of Orders No. 22-UI-200678 and 22-UI-200677 with EAB. On January 5, 2023, ALJ Kangas mailed letters stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue additional orders regarding these matters because the questionnaire response was late. These matters come before EAB based upon claimant's October 25, 2022 late applications for review of Orders No. 22-UI-200678 and 22-UI-200677.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 22-UI-200678 and 22-UI-200677. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2023-EAB-0067 and 2023-EAB-0068).

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's appellant

questionnaire response and other statements enclosed with their applications for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDINGS OF FACT: (1) Order No. 22-UI-200678, mailed to claimant on August 17, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-200678 at 2. Order No. 22-UI-200678 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than September 6, 2022."

(2) Order No. 22-UI-200677, mailed to claimant on August 17, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-200677 at 2. Order No. 22-UI-200677 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than September 6, 2022."

CONCLUSIONS AND REASONS: Claimant's late applications for review of Orders No. 22-UI-200678 and 22-UI-200677 are dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The applications for review of Orders No. 22-UI-200678 and 22-UI-200677 were due by September 6, 2022. Because claimant did not file their applications for review until October 25, 2022, the applications for review were late. Claimant provided a written statement with the applications for review. However, claimant's written statement did not describe the circumstances that prevented them from filing the applications for review on time. Accordingly, claimant did not show good cause for the late applications for review, and claimant's late applications for review are dismissed.

DECISION: The applications for review filed October 25, 2022 are dismissed. Orders No. 22-UI-200678 and 22-UI-200677 remain undisturbed.
