

**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-0069**

*Affirmed*  
*Late Request for Hearing Dismissed*

**PROCEDURAL HISTORY:** On June 21, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant filed a late claim for unemployment insurance benefits for the week of February 7, 2021 through February 13, 2021 (week 6-21) and therefore was denied benefits for that week (decision # 83606). On July 12, 2021, decision # 83606 became final without claimant having filed a request for hearing. On September 8, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on December 28, 2021 issued Order No 21-UI-182764, dismissing claimant's request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by January 11, 2022. On January 11, 2022, claimant filed a timely response to the appellant questionnaire. On April 6, 2022 the Office of Administrative hearings (OAH) mail a letter stating Order No. 21-UI-182764 was vacated and that a new hearing would be scheduled to determine whether claimant had good cause to file the late request for hearing and, if so, the merits of decision # 83606. On December 20, 2022, ALJ Logan conducted a hearing, and on December 21, 2022 issued Order No. 22-UI-210485, dismissing claimant's request for hearing as late without good cause and leaving decision # 83606 undisturbed. On January 10, 2023, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 22-UI-210485 is affirmed.
