

**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-0078**

*Affirmed*  
*Late Requests for Hearing Dismissed*

**PROCEDURAL HISTORY:** On June 24, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit work without good cause and was disqualified from receiving benefits effective March 7, 2021 (decision # 104836). On July 14, 2021, decision # 104836 became final without claimant having filed a request for hearing. On March 14, 2022, the Department served notice of an administrative decision based in part on decision # 104836, assessing an overpayment of \$2,310 in Pandemic Emergency Unemployment Compensation (PEUC) benefits and \$1,800 in Federal Pandemic Unemployment Compensation (FPUC) benefits claimant was liable to repay the Department (decision # 84342). On April 4, 2022, decision # 84342 became final without claimant having filed a request for hearing.

On April 7, 2022, claimant filed late requests for hearing on decisions # 104836 and 84342. ALJ Kangas considered the requests, and on July 19, 2022 issued Orders No. 22-UI-198490 and 22-UI-198487, dismissing the requests as late, subject to claimant's right to renew the requests by responding to an appellant questionnaire by August 2, 2022. On July 22, 2022, claimant filed a timely response to the appellant questionnaire. On August 11, 2022, the Office of Administrative Hearings (OAH) mailed two letters stating that Order No. 22-UI-198490 and Order No. 22-UI-198487 were vacated and that hearings would be scheduled to determine whether claimant's late requests for hearing should be allowed and, if so, the merits of decisions # 104836 and 84342. On December 20, 2022, ALJ Monroe conducted hearings, and on December 28, 2022 issued Orders No. 22-UI-211150 and 22-UI-211151, dismissing claimant's late requests for hearing as without good cause and leaving decisions # 104836 and 84342 undisturbed. On January 10, 2023, claimant filed applications for review of Orders No. 22-UI-211150 and 22-UI-211151 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 22-UI-211150 and 22-UI-211151. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2023-EAB-0078 and 2023-EAB-0077).

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 22-UI-211150 and 22-UI-211151 are affirmed.
