# EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0082

Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On November 4, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to provide information in accordance with the Department's rules and therefore was ineligible for unemployment insurance benefits for the weeks of October 9, 2022 through October 22, 2022 (weeks 41-22 through 42-22), and until the reason for the denial had ended (decision # 610465). Claimant filed a timely request for hearing. On December 12, 2022, ALJ Lucas conducted a hearing, and on December 20, 2022 issued Order No. 22-UI-210413, modifying decision # 610465 by concluding that claimant failed to provide information in accordance with the Department's rules and therefore was ineligible for benefits for the weeks of October 9, 2022 through November 5, 2022 (weeks 41-22 through 44-22). On January 9, 2023, Order No. 22-UI-210413 became final without claimant having filed an application for review. On January 11, 2023, claimant filed a late application for review with the Employment Appeals Board (EAB).

**FINDING OF FACT:** (1) Order No. 22-UI-210413, mailed to claimant on December 20, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-210413 at 3. Order No. 22-UI-210413 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before January 9, 2023 to be timely."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 22-UI-210413 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it

includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-210413 was due January 9, 2023. Because claimant did not file their application for review until January 11, 2023, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented claimant from filing the application for review by the January 9, 2023 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed January 11, 2023 is dismissed. Order No. 22-UI-210413 remains undisturbed.
