

**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-0092**

*Affirmed*  
*Request to Reopen Denied*

**PROCEDURAL HISTORY:** On February 3, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct, disqualifying claimant from receiving benefits beginning January 9, 2022 (decision # 134228). Claimant filed a timely request for hearing. On March 16, 2022, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for March 30, 2022. On March 30, 2022, claimant failed to appear at the hearing, and ALJ Lucas issued Order No. 22-UI-189994, dismissing claimant's request for hearing due to his failure to appear, leaving decision # 134228 undisturbed.

On April 12, 2022, claimant filed a timely request to reopen the March 30, 2022 hearing. On April 29, 2022, OAH served notice of a hearing scheduled for May 10, 2022 on whether claimant's request to reopen the March 30, 2022 hearing should be allowed. On May 10, 2022, claimant failed to appear at the hearing, and ALJ Wipperman issued Order No. 22-UI-193313, dismissing claimant's request to reopen the March 30, 2022 hearing due to his failure to appear, leaving Order No. 22-UI-189994 undisturbed.

On May 29, 2022, claimant filed a timely request to reopen the May 10, 2022 hearing. On December 16, 2022, OAH served notice of a hearing scheduled for December 27, 2022 on whether claimant's request to reopen the May 10, 2022 hearing should be allowed. On December 27, 2022, ALJ Chiller conducted the hearing, and on January 4, 2023 issued Order No. 23-UI-211631 denying claimant's request to reopen the May 10, 2022 hearing, leaving Order No. 22-UI-193313 undisturbed. On January 14, 2023, claimant filed an application for review of Order No. 23-UI-211631 with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** EAB did not consider claimant's written argument when reaching this decision because he did not include a statement declaring that he provided a copy of his argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 23-UI-211631 is affirmed.
