

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0101

Affirmed
Request for Hearing Dismissed

PROCEDURAL HISTORY: On June 15, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer with good cause and was not disqualified from receiving unemployment insurance benefits based on the work separation (decision # 122825). On June 25, 2021, the employer filed a timely request for hearing. On July 22, 2021, the Department mailed notice of an administrative decision concluding that the employer's account would be relieved of charges for benefits paid on claimant's claim because claimant voluntarily left work for reasons not attributable to the employer.

On December 27, 2022, the Office of Administrative Hearings (OAH) served notice of a hearing regarding the administrative decision dated June 15, 2021 (decision # 122825) to consider whether claimant should be disqualified from receiving benefits because of their work separation from the employer. On January 6, 2023, the employer withdrew its request for hearing, and ALJ Buckley issued Order No. 23-UI-211945, dismissing the employer's request for hearing and leaving decision # 122825 undisturbed. On January 13, 2023, the employer filed an application for review of Order No. 23-UI-211945 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered the employer's argument when reaching this decision. In their argument, the employer conceded that they withdrew their request for hearing on January 6, 2023, but asserted they did so based on the July 22, 2021 administrative decision relieving the employer of charges for benefits paid on claimant's claim, and not on the June 15, 2021 administrative decision allowing claimant benefits (decision # 122825). However, the employer filed its request for hearing on June 25, 2021, before the Department mailed notice of the July 22, 2021 administrative decision relieving the employer of charges. The December 27, 2022 notice of hearing specifically stated that the hearing was regarding the administrative decision dated June 15, 2021 (decision # 122825) to consider whether claimant should be disqualified from receiving benefits because of their work separation from the employer. The employer's request for hearing therefore was on decision # 122825, and their withdrawal of that request a withdrawal of their request for hearing on decision # 122825.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-211945 is affirmed.
