EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0111

Affirmed
Late Request to Reopen Dismissed

PROCEDURAL HISTORY: On June 13, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged by the employer for misconduct, disqualifying claimant from receiving benefits effective May 15, 2022 (decision # 120107). Claimant filed a timely request for hearing. On September 21, 2022, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for October 5, 2022. On October 5, 2022, claimant failed to appear at the hearing, and ALJ Krause issued Order No. 22-UI-204372, dismissing claimant's request for hearing due to his failure to appear, leaving decision # 120107 undisturbed. On October 25, 2022, Order No. 22-UI-204372 became final without claimant having filed a request to reopen the October 5, 2022 hearing. On January 2, 2023, claimant filed a late request to reopen the hearing. ALJ Kangas considered claimant's request, and on January 11, 2023 issued Order No. 23-UI-212311, dismissing the request as late without good cause, leaving Order No. 22-UI-204372 undisturbed. On January 18, 2023, claimant filed an application for review of Order No. 23-UI-212311 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant submitted written arguments on January 18, February 5, February 6, and February 11, 2023. EAB did not consider claimant's January 18 written argument because he did not declare that he provided a copy of his argument to the opposing party as required by OAR 471-041-0080(2)(a) (May 13, 2019). EAB did not consider claimant's February 5, 6 and 11, 2023 written arguments because they were not relevant and material to EAB's determination of whether claimant's request to reopen the October 5, 2022 was late without good cause. OAR 471-041-0090 (May 13, 2019).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-212311 is affirmed.
