# EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0112

## Affirmed Late Request for Hearing Dismissed

**PROCEDURAL HISTORY:** On March 9, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant failed to provide information in accordance with the Department's rules and therefore was not eligible for unemployment insurance benefits for the weeks including February 13, 2022 through March 5, 2022 (weeks 07-22 to 09-22), and until the reason for the denial had ended (decision # 82019). On March 29, 2022, decision # 82019 became final without claimant having filed a request for hearing. On June 14, 2022, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on September 22, 2022 issued Order No. 22-UI-203350, dismissing the request as late without a showing of good cause, subject to claimant failed to file an appellant questionnaire response. On October 12, 2022, claimant filed a timely application for review of Order No. 22-UI-203350 with the Employment Appeals Board (EAB). On January 14, 2023, ALJ Kangas mailed a letter to claimant stating that because claimant's response to the appellant questionnaire was late, the Office of Administrative Hearings (OAH) would not consider it or issue another order, and that Order No. 22-UI-203350 remained in effect. This matter comes before EAB based upon claimant's October 12, 2022 application for review of Order No. 22-UI-203350.

**FINDINGS OF FACT:** (1) On March 9, 2022, the Department mailed decision # 82019 to claimant's address of record. Decision # 82019 stated, "Your request for appeal must be received no later than March 29, 2022." Exhibit 1 at 2.

(2) On March 29, 2022, decision # 82019 became final without claimant having filed a request for hearing.

(3) On June 14, 2022 claimant filed a late request for hearing on decision # 82019.

CONCLUSIONS AND REASONS: Claimant's late request for hearing is dismissed

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day

deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist. Under OAR 471-040-0010(1)(b)(B), "good cause" does not include not understanding the implications of a decision or notice when it is received.

On March 9, 2022, the Department mailed decision # 82019 to claimant at claimant's address of record on file with the Department. The 20-day deadline for claimant to file a timely request for hearing on that decision was March 29, 2022. Claimant did not file a request for hearing on decision # 82019 until June 14, 2022. Accordingly, claimant's request for hearing was late.

Claimant failed to file a response to the appellant questionnaire and the record on review does not otherwise show why claimant failed to file their request for hearing by the March 29, 2022 deadline. Accordingly, claimant did not show good cause to extend the deadline to file a request for hearing on decision # 82019, or that they filed the late request for hearing within a reasonable time.

**DECISION:** Order No. 22-UI-203350 is affirmed.
