

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0134

Application for Review Dismissed

PROCEDURAL HISTORY: On November 1, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit work without good cause and was disqualified from receiving unemployment insurance benefits effective July 31, 2022 (decision # 122904). Claimant filed a timely request for hearing. On December 20, 2022, ALJ Ainardi conducted a hearing at which the employer did not appear, and on December 27, 2022 issued Order No. 22-UI-210922, affirming decision # 122904. On January 17, 2023, Order No. 22-UI-210922 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On January 23, 2023, claimant filed a late application for review with EAB.

FINDING OF FACT: Order No. 22-UI-210922, mailed to claimant on December 27, 2022, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed.” Order No. 22-UI-210922 at 4. Order No. 22-UI-210922 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before January 17, 2023 to be timely.”

CONCLUSION AND REASONS: Claimant’s late application for review is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-210922 was due January 17, 2023. Because claimant did not file their application for review until January 23, 2023, the application for review was late. Claimant’s application for review did not include a written statement describing the circumstances that

prevented claimant from filing the application for review by the January 17, 2023 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed January 23, 2023 is dismissed.
