

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0139

Late Application for Review Dismissed

PROCEDURAL HISTORY: On March 3, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective December 29, 2019 (decision # 94759). On March 23, 2021, decision # 94759 became final without claimant having filed a request for hearing. On September 14, 2022, filed a late request for hearing. On December 14, 2022, ALJ Chiller conducted a hearing, and on December 22, 2022 issued Order No. 22-UI-210739, dismissing claimant request for hearing as late without good cause and leaving decision # 94759 undisturbed. On January 11, 2023, Order No. 22-UI-210739 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On January 24, 2023, claimant filed a late application for review of Order No. 22-UI-210739 with EAB.

FINDING OF FACT: (1) Order No. 22-UI-210739, mailed to claimant on December 22, 2022, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed.” Order No. 22-UI-210739 at 3. Order No. 22-UI-210739 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before January 11, 2023 to be timely.”

CONCLUSIONS AND REASONS: Claimant’s late application for review of Order No. 22-UI-210739 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-210739 was due by January 11, 2023. Because claimant did not file their application for review until January 24, 2023, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented him from filing the application for review by the January 11, 2023 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed January 24, 2023 is dismissed. Order No. 22-UI-210739 remains undisturbed.
