

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0148

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On November 23, 2001, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits beginning October 17, 2021 because she was discharged by the employer for misconduct (decision # 55740). On December 13, 2021, decision # 55740 became final without claimant having filed a request for hearing. On February 24, 2022 claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on May 25, 2022 issued Order No. 22-UI-194698 dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by June 8, 2022.

Claimant filed a timely response to the appellant questionnaire. On August 24, 2022, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 22-UI-194698 was cancelled and vacated, and that a hearing would be scheduled to address whether claimant's late request for hearing should be allowed and, if so, the merits of decision # 55740. On September 2, 2022, OAH served notice that the hearing was scheduled for September 12, 2022. On September 12, 2022, claimant failed to appear at the hearing, and on September 13, 2022 ALJ Roberts issued Order No. 22-UI-202488, dismissing claimant's request for hearing for failure to appear, and leaving decision # 55740 undisturbed.

Claimant filed a request to reopen the September 12, 2022 hearing. ALJ Kangas considered claimant's request to reopen, and on January 11, 2023 issued Order No. 23-UI-212298, denying the request by concluding that claimant failed to establish good cause for failing to appear at the hearing, and leaving 22-UI-202488 undisturbed. On January 26, 2023, claimant filed an application for review of Order No. 23-UI-212298 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant did not declare that she provided a copy of her argument to the opposing party as required by OAR 471-041-0080(2)(a) (May 13, 2019). Nor was the argument relevant and material to EAB's determination of whether claimant had good cause for failing to appear at the

September 12, 2022 hearing. EAB therefore did not consider claimant's written argument when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-212298 is affirmed.
