EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0151

Late Application for Review Dismissed

PROCEDURAL HISTORY: On May 4, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that that claimant failed to register for work in accordance with the Department's rules and was ineligible for benefits from April 17, 2022 through April 23, 2022 (week 16-22), and until the reason for the denial had ended. On May 24, 2022, the May 4, 2022 administrative decision became final without claimant having filed a request for hearing. On August 8, 2022, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on November 9, 2022 issued order No. 22-UI-207038, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by November 23, 2022. On November 29, 2022, Order No. 22-UI-207038 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On December 20, 2022, a second copy of Order No. 22-UI-207038 was emailed to claimant. On January 22, 2023, claimant filed a late response to the appellant questionnaire and a late application for review by EAB. On January 26, 2023, ALJ Kangas mailed a letter to claimant stating that because claimant's response to the appellant questionnaire was late, the Office of Administrative Hearings (OAH) would not consider it or issue another order, and that Order No. 22-UI-207038 remained in effect. This matter comes before EAB based upon claimant's January 22, 2023 late application for review of Order No. 22-UI-207038.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement claimant provided with their late application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 22-UI-207308, mailed to claimant on November 9, 2022 and emailed to claimant on December 20, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-207308 at 2. Order No. 22-UI-207308 also stated on its Certificate

of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than November 29, 2022."

CONCLUSION AND REASONS: Claimant's late application for review is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-207038 was due November 29, 2022. Because claimant did not file their application for review until January 22, 2023, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented claimant from filing the application for review on time, as required under OAR 471-041-0070(3).

A copy of Order No. 22-UI-207038 was emailed to claimant on December 20, 2022, suggesting claimant may not have received the copy mailed to them on November 9, 2022. Circumstances beyond claimant's reasonable control therefore may have prevented claimant from filing their application for review by the November 29, 2022 filing deadline. However, claimant's written statement did not describe other circumstances preventing them from filing their application for review by December 27, 2022, a reasonable time (seven days) after the circumstances that may have prevented a timely filing apparently ceased to exist. Accordingly, claimant did not show good cause to extend the filing deadline to January 22, 2023, and claimant's late application for review is dismissed.

DECISION: The application for review filed January 22, 2023 is dismissed. Order No. 22-UI-207038 remains undisturbed.
