EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0158

Affirmed
Late Request for Hearing Allowed
Ineligible for Pandemic Unemployment Assistance
Overpayment and Penalties

PROCEDURAL HISTORY: On March 22, 2022, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not eligible for PUA benefits effective March 8, 2020. On April 11, 2022, the March 22, 2022 PUA determination became final without claimant having filed a request for hearing. On April 15, 2022, the Department served notice of an administrative decision, based in part on the March 22, 2022 administrative decision, concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain benefits and assessing an overpayment of \$15,580 in PUA benefits, \$21,000 in Federal Pandemic Unemployment Compensation (FPUC) benefits, and \$1,800 in Lost Wages Assistance (LWA) benefits, and a \$5,487 monetary penalty. On April 26, 2022, claimant filed a late request for hearing on the March 22, 2022 PUA determination and a timely request for hearing on the April 15, 2022 administrative decision.

On January 5, 2023, ALJ Roberts conducted a hearing regarding the March 22, 2022 PUA determination and the April 15, 2022 administrative decision. On January 13, 2023, ALJ Roberts issued Order No. 23-UI-212537, allowing claimant's late request for hearing on the March 22, 2022 PUA determination and affirming that decision by concluding that claimant was not eligible for PUA benefits from February 23, 2020 through September 4, 2021 (weeks 09-20 through 35-21). Also on January 13, 2023, ALJ Roberts issued Order No. 23-UI-212631, affirming the April 15, 2022 administrative decision. On February 1, 2023, claimant filed an application for review with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-212537 and 23-UI-212631. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2023-EAB-0158 and 2023-EAB-0157).

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented

him from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's argument to the extent it was based on the record.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 23-UI-212537 and 23-UI-212631 are affirmed.
