EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0166

Late Application for Review Dismissed

PROCEDURAL HISTORY: On September 21, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct and claimant was therefore disqualified from receiving unemployment insurance benefits effective August 14, 2022 (decision # 134713). Claimant filed a timely request for hearing. On November 3, 2022, ALJ Taylor conducted a hearing, and on November 7, 2022 issued Order No. 22-UI-206732, affirming decision # 134713. On November 28, 2022, Order No. 22-UI-206732 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On December 15, 2022, claimant filed a late application for review with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's written statement in her application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: Order No. 22-UI-206732, mailed to claimant on November 7, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-206732 at 5. Order No. 22-UI-206732 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before November 28, 2022 to be timely."

CONCLUSION AND REASONS: Claimant's late application for review is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-

0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-206732 was due November 28, 2022. Because claimant did not file their application for review until December 15, 2022, the application for review was late. Claimant provided a written statement with the application for review. However, claimant discussed only the reasons why they disagreed with the order under review. Claimant failed to assert any circumstances they faced that prevented them from timely filing the application for review. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed November 2, 2022 is dismissed. Order No. 22-UI-206732 remains undisturbed.
