# EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0176

## Affirmed Late Request for Hearing Dismissed

**PROCEDURAL HISTORY:** On December 22, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit work without good cause and was disqualified from receiving benefits effective February 16, 2020 (decision # 135513). On January 11, 2021, decision # 135513 became final without claimant having requested a hearing. On April 14, 2022, the Department served notice of an administrative decision based in part on decision # 135513, concluding that claimant was overpaid \$1591 in unemployment insurance benefits, \$685 in Pandemic Emergency Unemployment Compensation (PEUC), and \$9,600 in Federal Pandemic Unemployment Compensation (FPUC) that claimant was required to repay to the Department (decision # 172148). On May 4, 2022, decision # 172148 became final without claimant having requested a hearing. On July 26, 2022, claimant filed a late request for hearing on decisions #135513 and # 172148. ALJ Kangas considered claimant's request, and on October 26, 2022, issued Orders No. 22-UI-205901 and 22-UI-205902, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by November 9, 2022. On November 14, 2022, claimant filed an application for review of Orders No. 22-UI-205901 and 22-UI-205902 with the Employment Appeals Board (EAB). On December 14, 2022, ALJ Kangas mailed letters to claimant stating that because claimant did not file a timely response to the appellant questionnaire, Orders No. 22-UI-205901 and 22-UI-205902 remained in effect. This matter comes before EAB based upon claimant's November 14, 2022 application for review of Orders No. 22-UI-205901 and 22-UI-205902.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 22-UI-205901 and 22-UI-205902. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2023-EAB-0176 and 2023-EAB-0177).

**FINDINGS OF FACT:** (1) On December 22, 2020, the Department mailed decision # 135513 to claimant's address of record. Decision # 135513 became final on January 11, 2021 without claimant having requested a hearing.

(2) On April 14, 2022, the Department mailed decision # 172148 to claimant's address of record. Decision # 172148 became final on May 4, 2022 without claimant having requested a hearing.

(3) On July 26, 2022, claimant requested a hearing on decisions # 135513 and 172148.

(4) Claimant did not submit a response to the appellant questionnaire that was mailed to them on October 26, 2022, and has provided no other information as to why their request for hearing on decision # 135513 and decision # 172148 was not timely filed.

**CONCLUSIONS AND REASONS:** Claimant's late request for hearing on decisions # 135513 and 172148 are dismissed.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

A request for hearing on decision # 135513 was due by January 11, 2021. A request for hearing on decision # 172148 was due by May 4, 2022. Because claimant did not file their request for hearing until July 26, 2022, the request was late. Claimant has not provided an explanation for why their request for hearing on decision # 135513 and decision # 172148 was not timely filed. The record does not otherwise demonstrate good cause for extending the deadline to timely request a hearing on either administrative decision. Therefore, the request for hearing on decision # 135513 and decision # 13

DECISION: Orders No. 22-UI-205901 and 22-UI-205902 are affirmed.
