

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0185

Application for Review Dismissed
No Justiciable Controversy

PROCEDURAL HISTORY AND FINDINGS OF FACT: On February 18, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct and claimant was therefore disqualified from receiving unemployment insurance benefits effective January 23, 2022 (decision # 133345). On March 10, 2022, decision # 133345 became final without claimant having filed a request for hearing. On March 14, 2022, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on June 15, 2022, issued Order No. 22-UI-196128 dismissing claimant's request for hearing as late, subject to his right to renew the request by responding to an appellant questionnaire by June 29, 2022. On June 28, 2022, claimant filed a timely response to the appellant questionnaire. On August 18, 2022, the Office of Administrative Hearings (OAH) mailed claimant a letter stating that Order No. 22-UI-196128 was cancelled and that the matter would be scheduled for a hearing to determine if claimant had good cause for failing to timely file his request for hearing, and if so, the merits of decision # 133345. On October 24, 2022 and November 15, 2022, ALJ Adamson conducted a hearing, and on November 21, 2022, issued Order No. 22-UI-207803, reversing decision # 133345 by concluding that the employer discharged claimant, but not for misconduct, and claimant was not disqualified from receiving benefits based on the work separation. On December 2, 2022, claimant filed an application for review of Order No. 22-UI-207803 with the Employment Appeals Board (EAB).

CONCLUSIONS AND REASONS: Claimant's application for review of Order No. 22-UI-207803 presents no justiciable controversy and is dismissed.

On December 2, 2022, claimant filed with the Employment Appeals Board (EAB) an application for review of an order that allowed the appellant benefits. Claimant did not assign error to any portion of that order, did not request reversal of any portion of the order, and alleged no facts entitling him to further relief in this matter. Accordingly, there is no justiciable controversy before EAB based upon claimant's application for review. *See accord Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995). Because the case before EAB presents no justiciable controversy, the application for review of Order No. 22-UI-207803 is dismissed and the order remains undisturbed.

DECISION: The application for review filed December 2, 2022 is dismissed. Order No. 22-UI-207803 remains undisturbed.
