EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0195

Late Application for Review Dismissed

PROCEDURAL HISTORY: On June 14, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct, disgualifying claimant from receiving unemployment insurance benefits effective September 13, 2020 (decision # 83534). On July 6, 2021, decision # 83534 became final without claimant having filed a request for hearing. On July 19, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on August 3, 2021 issued Order No. 21-UI-171634, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by August 17, 2021. On August 23, 2021, Order No. 21-UI-171634 became final without claimant having responded to the appellant questionnaire or filed an application for review with the Employment Appeals Board (EAB). On August 22, 2022, claimant faxed a document to the Office of Administrative Hearings (OAH) that OAH treated as a late response to the appellant questionnaire. On September 12, 2022, ALJ Kangas mailed a letter stating that OAH would not consider claimant's questionnaire response or issue another order regarding this matter because the questionnaire response was late. On September 20, 2022, claimant faxed another document to OAH that EAB construed as a late application for review of Order No. 21-UI-171634. This matter comes before EAB based on claimant's late application for review of Order No. 21-UI-171634.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement claimant provided with their application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 21-UI-171634, mailed to claimant on August 3, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-171634 at 2.

Order No. 21-UI-171634 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than August 23, 2021."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 21-UI-171634 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-171634 was due by August 23, 2021. Because claimant did not file their application for review until September 20, 2022, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented claimant from filing the application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed September 20, 2022 is dismissed. Order No. 21-UI-171634 remains undisturbed.
