EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0195-R

Late Request for Reconsideration Dismissed EAB Decision 2023-EAB-0195 Remains Undisturbed

PROCEDURAL HISTORY: On June 14, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct, disqualifying claimant from receiving unemployment insurance benefits effective September 13, 2020 (decision #83534). On July 6, 2021, decision #83534 became final without claimant having filed a request for hearing. On July 19, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on August 3, 2021 issued Order No. 21-UI-171634, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by August 17, 2021. On August 23, 2021, Order No. 21-UI-171634 became final without claimant having responded to the appellant questionnaire or filed an application for review with the Employment Appeals Board (EAB). On August 22, 2022, claimant faxed a document to the Office of Administrative Hearings (OAH) that OAH treated as a late response to the appellant questionnaire. On September 12, 2022, ALJ Kangas mailed a letter stating that OAH would not consider claimant's questionnaire response or issue another order regarding this matter because the questionnaire response was late. On September 20, 2022, claimant faxed another document to OAH that EAB construed as a late application for review of Order No. 21-UI-171634. On February 14, 2023, EAB issued EAB Decision 2023-EAB-0195 dismissing claimant's late application for review of Order No. 21-UI-171634. On March 17, 2023, claimant filed a request for reconsideration with EAB.

This decision is issued pursuant to EAB's authority under ORS 657.290(3).

CONCLUSIONS AND REASONS: Claimant's request for reconsideration is dismissed. EAB Decision 2023-EAB-0195 remains undisturbed.

ORS 657.290(3) authorizes the Employment Appeals Board to reconsider any previous decision of the Employment Appeals Board, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment

Department practice." OAR 471-041-0145(1) (May 13, 2019). The request is subject to dismissal unless it includes a statement that a copy was provided to the other parties, and is filed on or before the 20th day after the decision sought to be reconsidered was mailed. OAR 471-041-0145(2).

On February 14, 2023, EAB issued EAB Decision 2023-EAB-0195. Claimant did not file their request for reconsideration with EAB until March 17, 2023. Accordingly, claimant's request for reconsideration was filed more than 20 days after the decision was mailed and is late. OAR 471-041-0145(2) contains no exception to the requirements that a request for reconsideration must be filed on or before the 20th day after the decision sought to be reconsidered was mailed. Further, claimant's request for reconsideration did not include any statement that claimant provided a copy of the request for reconsideration to the employer as required. For these reasons, claimant's request for reconsideration is dismissed.

DECISION: Claimant's request for reconsideration is dismissed. 2023-EAB-0195 remains undisturbed. Order No. 21-UI-171634 remains undisturbed.
