

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0197

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On August 17, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits from May 15 through July 23, 2022 because claimant's weekly claims for that period were late (decision # 80901). On September 6, 2022, decision # 80901 became final without claimant having filed a request for hearing. On September 10, 2022, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on December 22, 2022 issued Order No. 22-UI-210812, dismissing the request as late, subject to claimant's right to review the request by responding to an appellant questionnaire by January 5, 2023. On January 5, 2023, however, OAH served notice of a hearing scheduled for January 18, 2023 to consider, in part, whether claimant's late request for hearing should be allowed and, if so, whether claimant filed timely continued claims for benefits. On January 18, 2023, ALJ Kaneshiro conducted the hearing and issued Order No. 23-UI-212988, dismissing claimant's late request for hearing and leaving decision # 80901 undisturbed. On February 6, 2023, claimant filed an application for review of Order No. 23-UI-212988 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-212988 is affirmed.
