EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0200

Late Application for Review Dismissed

PROCEDURAL HISTORY: On September 27, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to register for work in accordance with the Department's rules and therefore was ineligible to receive unemployment insurance benefits for the week of September 4, 2022 through September 10, 2022 (week 36-22) and until the reason for the denial had ended. Claimant filed a timely request for hearing. On January 19, 2023, ALJ Griffin conducted a hearing, and issued Order No. 23-UI-213130, modifying the September 27, 2022 administrative decision by concluding that claimant had failed to register for work and was ineligible for benefits for the period of September 4, 2022 through October 1, 2022 (weeks 36-22 through 39-22). On February 8, 2023, Order No. 23-UI-213130 became final without claimant having filed an application for review. On February 9, 2023, claimant filed a late application for review with the Employment Appeals Board (EAB).

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's application for review and the postmarked envelope containing claimant's application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 23-UI-213130, mailed to claimant on January 19, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-213130 at 4. Order No. 23-UI-213130 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before February 8, 2023 to be timely."

(2) Claimant's application for review of Order No. 23-UI-213130 was filed on February 9, 2023.

¹ Although Order No. 23-UI-213130 stated that it affirmed the September 27, 2022 administrative decision, it modified that decision by changing the ineligibility dates. Order No. 23-UI-213130 at 4.

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 23-UI-213130 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The filing date for an application for review filed by mail is the postmark date affixed to the envelope in which the application was mailed. OAR 471-041-0065(1)(b) (May 13, 2019). The postmark date on the envelope in which claimant mailed their application for review was February 9, 2023; that date is therefore the filing date. The application for review of Order No. 23-UI-213130 was due February 8, 2023. Because claimant did not file their application for review until February 9, 2023, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented claimant from filing the application for review by the February 8, 2023 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed February 9, 2023 is dismissed. Order No. 23-UI-213130 remains undisturbed.
