# EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0201

Affirmed
Request to Backdate Initial Claim Denied
Ineligible Weeks 15-21 through 19-21

**PROCEDURAL HISTORY:** On October 5, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision denying claimant's request to backdate her initial claim to April 11, 2021 and concluding that she was ineligible for benefits from April 11 through May 15, 2021 (weeks 15-21 through 19-21) (decision # 104450). Claimant filed a timely request for hearing. On January 19, 2023, ALJ Ramey conducted a hearing, and on January 27, 2023 issued Order No. 23-UI-213969 affirming decision # 104450. On February 10, 2023, claimant filed an application for review with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** EAB considered claimant's written argument in reaching this decision. In his written argument, claimant asserted that the order under review inaccurately stated that he had the burden of proof to show that he was eligible for benefits. Claimant's Written Argument at 2. Under *Nichols v. Employment Division*, 24 Or App 195, 544 P2d 1068 (1976), where the Department has paid benefits, it has the burden to prove benefits should not have been paid; by logical extension of that principle, where benefits have not been paid, claimant has the burden to prove that the Department should have paid benefits.

Here, claimant was not paid benefits for weeks 15-21 through 17-21, and therefore bears the burden of proof that he was eligible for those benefits. Conversely, for weeks 18-21 and 19-21, claimant was paid benefits, and therefore it is the Department's burden of proof. However, regardless of which party had the burden of proof, it was uncontested that claimant did not successfully make his initial claim for benefits until May 26, 2021, and he therefore was ineligible for benefits for the all of the weeks at issue. Claimant's argument also cited the advice he received from the Department's representative and the hardship that repaying benefits would cause claimant. Claimant's Written Argument at 3. If claimant is assessed an overpayment, those facts can be relevant to a request for a waiver of that overpayment. However, there is no good cause exception, including financial hardship, to the filing deadlines at issue in the order under review.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 23-UI-213969 is affirmed.
