

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0220

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On August 2, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant had failed to provide information to the Department and was therefore not eligible to receive unemployment insurance benefits for the week of July 17, 2022 through July 23, 2022 (week 29-22) and until the reason for the denial ended (decision # 133121). On August 22, 2022, decision # 133121 became final without claimant having filed a request for hearing. On August 31, 2022, claimant filed a late request for hearing on decision # 133121. ALJ Kangas considered claimant's request, and on December 6, 2022 issued Order No. 22-UI-209068, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by December 20, 2022. On December 19, 2022, claimant filed a timely response to the appellant questionnaire. ALJ Kangas considered claimant's response, and on February 6, 2023 issued Order No. 23-UI-214919, canceling Order No. 22-UI-209068, re-dismissing claimant's late request for hearing, and leaving decision # 133121 undisturbed. On February 14, 2023, claimant filed an application for review of Order No. 23-UI-214919 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-214919 is affirmed.
