# EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0230

#### Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On November 3, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to provide information in accordance with the Department's rules and was not eligible for benefits from October 9 through 29, 2022 (weeks 41-22 through 43-22) and until the reason for denial had ended (decision # 610406). Claimant filed a timely request for hearing. On December 6, 2022, ALJ Janzen conducted a hearing, and on December 7, 2022, issued Order No. 22-UI-209103, modifying decision # 610406 by concluding that claimant failed to provide information in accordance with the Department's rules and was not eligible for benefits from October 9 through November 5, 2022 (weeks 41-22 through 44-22). On December 27, 2022, Order No. 22-UI-209103 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On February 16, 2023, claimant filed a late application for review with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's written statement submitted with their application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**FINDING OF FACT:** (1) Order No. 22-UI-209103, mailed to claimant on December 7, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-209103 at 4. Order No. 22-UI-209103 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before December 27, 2022 to be timely."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 22-UI-209103 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-209103 was due December 27, 2022. Because claimant did not file their application for review until February 16, 2023, the application for review was late. Claimant provided a written statement with their application for review. However, claimant discussed only the reasons why they disagreed with the conclusions of the order under review. Claimant failed to assert any circumstances they faced that prevented them from timely filing their application for review. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed February 16, 2023 is dismissed. Order No. 22-UI-209103 remains undisturbed.
