

**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-0234**

*Affirmed*  
*Requests to Reopen Allowed*  
*Eligible Week 38-20*  
*Ineligible Weeks 39-20 through 18-21 and 21-21 through 25-21*

**PROCEDURAL HISTORY:** On July 7, 2021, the Oregon Employment Department (the Department) served notice of four administrative decisions concluding that claimant filed a late claim for unemployment insurance benefits for the weeks including September 13, 2020 through March 20, 2021 (weeks 38-20 through 11-21), April 25, 2021 through May 8, 2021 (weeks 17-21 through 18-21), March 21, 2021 through April 24, 2021 (weeks 12-21 through 16-21), and May 23, 2021 through June 26, 2021 (weeks 21-21 through 25-21), and therefore was denied benefits for those weeks (decisions # 94910, # 100548, # 100245, and # 100823). Claimant filed timely requests for hearing. On August 10, 2021, the Office of Administrative Hearings (OAH) served notice of a consolidated hearing scheduled for August 24, 2021. On August 24, 2021, claimant failed to appear at the hearing, and ALJ Scott issued Order Nos. 21-UI-173211, 21-UI-173213, 21-UI-173210, and 21-UI-173218, dismissing claimant's requests for hearing due to his failure to appear. On September 2, 2021, claimant filed a timely request to reopen the August 24, 2021 hearing.

On January 11, 2023 and continuing on January 26, 2023, ALJ Mott conducted a consolidated hearing, and on January 27, 2023 issued Order Nos. 23-UI-213942, 23-UI-213941, 23-UI-213940, and 23-UI-213939, allowing claimant's request to reopen the August 24, 2021 hearing, modifying decision # 94910 by concluding that claimant timely filed his claim and was eligible for benefits for the week of September 13, 2020 through September 19, 2020 (week 38-20), but that claimant filed late claims and was ineligible for benefits for the weeks of September 20, 2020 through March 20, 2021 (weeks 39-20 through 11-21), and affirming decisions # 100548, # 100245, and # 100823. On February 16, 2023, claimant filed applications for review of Order Nos. 23-UI-213942, 23-UI-213941, 23-UI-213940, and 23-UI-213939 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Order Nos. 23-UI-213942, 23-UI-213941, 23-UI-213940, and 23-UI-213939. For case-tracking purposes, this decision is being issued in quadruplicate (EAB Decisions 2023-EAB-0234, 2023-EAB-0235, 2023-EAB-0236, and 2023-EAB-0237).

**WRITTEN ARGUMENT:** EAB considered claimant’s written argument in reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order Nos. 23-UI-213942, 23-UI-213941, 23-UI-213940, and 23-UI-213939 are affirmed.
