

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0242

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On September 30, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant filed late claims for benefits for the weeks from March 7 through 20, 2021 (weeks 10-21 through 11-21) and March 28 through May 8, 2021 (weeks 13-21 through 18-21), and therefore was ineligible for benefits for those weeks (decision # 123322). On October 20, 2021, decision # 123322 became final without claimant having filed a request for hearing. On February 15, 2022, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on May 16, 2022 issued Order No. 22-UI-193832, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by May 30, 2022. Claimant filed a response to the appellant questionnaire. On August 24, 2022, OAH mailed a letter stating that Order No. 22-UI-193832 was vacated and that a new hearing would be scheduled to determine whether claimant's late request for hearing should be allowed and, if so, the merits of decision # 123322. On February 2, 2023, ALJ Chiller conducted a hearing, and on February 10, 2023 issued Order No. 23-UI-215692, dismissing claimant's request for hearing as late without good cause and leaving decision # 123322 undisturbed. On February 21, 2023, claimant filed an application for review of Order No. 23-UI-215692 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-215692 is affirmed.
