

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0245

Affirmed
Request to Reopen Allowed
Overpayment Waiver Granted

PROCEDURAL HISTORY: On September 20, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision denying claimant's request for a waiver of a \$570 overpayment of regular unemployment insurance (UI) benefits that the Department had previously assessed on June 7, 2022 (decision # 141134). Claimant filed a timely request for hearing. On October 27, 2022, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for November 21, 2022. On November 21, 2022, claimant failed to appear at the hearing, and on November 28, 2022, ALJ Monroe issued Order No. 22-UI-208195, dismissing claimant's request for hearing due to her failure to appear. On December 6, 2022, claimant filed a timely request to reopen the November 21, 2022 hearing. On January 23, 2023, ALJ Monroe conducted a hearing, and on January 31, 2023 issued Order No. 23-UI-214352, allowing claimant's request to reopen the November 21, 2022 hearing and reversing decision # 141134 by granting claimant's request for a waiver of the overpayment. On February 21, 2023, the Department filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered the Department's written argument in reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-214352 is affirmed.
