

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0247

Affirmed
Requests to Reopen Denied

PROCEDURAL HISTORY: On December 15, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work for the weeks including May 10, 2020 through June 27, 2020 (weeks 20-20 to 26-20) and was therefore not eligible to receive unemployment insurance benefits during those weeks and until the reason for denial had ended (decision # 84829). On December 15, 2020, the Department also served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was therefore disqualified from receiving benefits effective December 1, 2019 (decision # 101036). Claimant filed timely requests for hearing on decision # 84829 and decision # 101036. On August 31, 2022, the Office of Administrative Hearings (OAH) served notice of hearings scheduled for September 9, 2022. On September 9, 2022, claimant failed to appear at the hearings, and ALJ Griffin issued Orders No. 22-UI-202382 and 22-UI-202383, dismissing claimant's requests for hearing due to claimant's failure to appear. On September 13, 2022, claimant filed timely requests to reopen the September 9, 2022 hearings. ALJ Kangas considered claimant's requests, and on February 9, 2023, issued Orders No. 23-UI-215365 and 23-UI-215364, concluding that claimant did not have good cause to reopen the September 9, 2022 hearings, and leaving Orders No. 22-UI-202382 and 22-UI-202383 undisturbed.¹ On February 21, 2023, claimant filed an application for review of Orders No. 23-UI-215365 and 23-UI-215364 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-215365 and 23-UI-215364. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2023-EAB-0246 and 2023-EAB-0247).

WRITTEN ARGUMENT: EAB considered claimant's written argument in reaching this decision.

¹ Orders No. 23-UI-215365 and 23-UI-215364 cancelled and replaced Orders No. 23-UI-215263 and 23-UI-215262, which were issued in error on February 8, 2023.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 23-UI-215365 and 23-UI-215364 are affirmed.
