

**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-0248**

*Affirmed*  
*Late Request for Hearing Dismissed*

**PROCEDURAL HISTORY:** On October 26, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was therefore disqualified from receiving unemployment insurance benefits effective October 2, 2022 (decision # 132608). On November 15, 2022, decision # 132608 became final without claimant having filed a request for hearing. On December 9, 2022, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on December 22, 2022, issued Order No. 22-UI-210720, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by January 5, 2023. On January 5, 2023, claimant filed a response to the appellant questionnaire. On January 17, 2023, the Office of Administrative Hearings (OAH) mailed a letter cancelling Order No. 22-UI-201720 and stating that the matter would be scheduled for a hearing to determine if claimant had good cause to file their late request for hearing, and if so, the merits of decision # 132608. On January 30, 2023, ALJ Smith conducted a hearing at which the employer failed to appear, and on February 3, 2023 issued Order No. 23-UI-214771, re-dismissing claimant's request for hearing as late without good cause and leaving decision # 132608 undisturbed. On February 22, 2023, claimant filed an application for review of Order No. 23-UI-214771 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 23-UI-214771 is affirmed.
